

Fifth Amendment to the Rustic Ridge Homeowner's Association By-Laws

Whereas, Grasinger Homes, Inc., a Pennsylvania Corporation is the owners of all the numbered lots in a certain plan of lots situate in the Borough of Plum, County of Allegheny and Commonwealth of Pennsylvania, known as the Rustic Ridge Plan of Lots No. 6 and 6A which has been recorded in the Recorder's Office of Allegheny County, Pennsylvania in Plan Book Volume 236, Pages 46 to 53 inclusive and Plan Book 244, Page 171, respectively.

Whereas, the undersigned as owner of all the numbered lots in said Plan desires to adopt the Rustic Ridge Homeowner's Association By-Laws as recorded in Deed Book Volume 9073, Page 537; and

Whereas, the undersigned desires to dedicate the Common Areas known as Unit 9, 10 and 11 on the Plan and as indicated on Exhibit "A" attached hereto to be added to the Rustic Ridge Homeowner's Association.

Now Therefore, be it known that the undersigned, as such owners, does hereby adopt the following to which all of the numbered lots in the said Plan to be held or to be conveyed by it shall be subject.

- (a) The Rustic Ridge Homeowner's Association By-Laws are hereby adopted as above recorded and shall subject Grasinger Homes, Inc., it's successors and assigns to the terms contained herein.
- (b) Grasinger Homes, Inc., dedicates the common areas as more specifically set forth in Exhibit "A" attached hereto and made a part hereof for the use, benefit and enjoyment of the residents of Rustic Ridge Plan of Lots 1, 2, 3, 4A, 5, 6 and 6A as recorded in the Recorder's Office of Allegheny County, Pennsylvania at Plan Book Volume 178, pages 21 to 26 and Plan Book Volume 187, pages 183 to 188, and Plan Book Volume 201, pages 27 to 32, Plan Book Volume 213, pages 11 to 16, and Plan Book Volume 218, pages 29 to 34, an Plan Book Volume 236, page 46-53 and Plan Book Volume 244, page 171 respectively and further additions thereto.
